RE: FSL 2022-23 CLUB LICENSING REQUIREMENTS AND POINTS SCORING METHOD.

The 2022-23 Futsal Super League (FSL) is scheduled to kick off on Sunday 21st May 2023 and all participating clubs will undergo club licensing to obtain a license to participate.

All clubs intending to participate in the FSL 2021-22 season will submit requirements prior to being inspected.

Clubs that attain a score of 80% and above will be eligible for inspection to be granted a license to participate in the FSL 2022-23 season.

The deadline for clubs to apply in writing will be at 5:00 PM on Friday 5th May 2023.

Please see the annexed document that shows a breakdown of the FSL 2022-23 Club Licensing points scoring method and the fees structure.
